NEBRASKA 2019/20 CE Course Requirements

18 CE Hours Required: 6hrs "R" Optional: 6hrs "T")	*6 hours of the 18 hours MUST be an "R" CE Approved class...Course #'s ending in "R" (#0000R) *6 hours of the 18 hours MAY be Broker Approved Training-BAT Courses #'s ending in "T" (9999T) ARE OPTIONAL AND NOT REQUIRED CE CURRICULUM! <i>BAT classes can be repeated.</i>
By November 2019 (Odd Years)	If your license was issued: 1985 or earlier or in one of the following years: 1987, 1989, 1991, 1993, 1995, 1997, 1999, 2001/03/05/07/09/11/13/15/17.
By November 2020 (Even Years)	If your license was issued: 1986, 1988, 1990, 1992, 1994, 1996, 1998, 2000/02/04/06/08/10/12/14/16/18
By December 31, 2020 NAR'S REQUIRED ETHIC TRAINING	To meet the National REALTORS Association's ETHICS TRAINING BIENNIAL requirement... you must complete a NAR approved Ethics Training course between 1/1/19 to 12/31/20.
TEAMS CE Class REQUIRED	"Teams" CE Class is required every 4 years (2 renewal periods) for licensed team leaders/members, broker and manager of teams and/or within 180 days of a licensee joining a team.
Property Management CE Class REQUIRED	On your real estate license application (or renewal) ...if you selected that you are engaged in or intend to be engaged in property management... in the next two-year licensing period you are required to take a Property Management CE Course. The NREC approved CE course will have an "RPM" course number... (#0000RPM)

To Avoid Taking Duplicate CE Courses:

Please verify your completed CE Courses (already taken) by double checking your Nebraska CE Course/Hours records at: www.nrec.ne.gov. You can repeat any "R" class in a renewal period, any only repeat a regular CE class every four years plus one or more days...from the exact date of the class!

CE and BAT Certificates:

Keep a copy of your CE and BAT Certificates for your records; **Do NOT** send your Certificates to the Nebraska Real Estate Commission!

New Licensees Educational Notice:

New licensees DO NOT receive CE/BAT credits for any classes taken in the first year of licensing! This includes those that have secured a NEW broker license in any year.
